GOVERNMENT ASSISTANCE

The IRD have a range of tax and income assistance available for people whose business has been affected by COVID-19.

As stated on the IRD website:

If your business is unable to pay its taxes on time due to the impact of COVID-19, we understand - you don't need to contact us right now. Get in touch with us when you can, and we'll write-off any penalties and interest. It would help if you continue to file however, as the information is used to make correct payments to people, and to help the Government continue to respond to what is happening in the economy.

If you normally use a Tax Agent it is encouraged to continue to work them, they will have an understanding of the assistance IRD have announced and will be able to work with you on the right solutions for your business.

KAITAKAWAENGA MĀORI

Inland Revenue have Kaitakawaenga Māori support the Māori Community. Kaitakawaenga Māori deliver Inland Revenue services in a whānau, hapū and iwi centric way to help ensure Māori customers have the tools to self-manage their tax affairs.

This is a service where Māori are supporting Māori and IRD working hard to provide essential services for business and individual customers during this stressful and difficult time.
